- Sky Rocket Sectional- Judy Knox
- A discussion was held regarding the Sky Rocket Sectional and the fact that we were down by 80.5 tables. We had a net loss of \$1,500.
   There was a lot of discussion regarding ways to pump up attendance and to reduce our expenses. The following actions will be made in order to improve the attendance for the next Nate Silverstein and Sky Rocket Tournaments subject to approval by Charlie MacCracken.

  - 4 Bob Williams has taken over as hospitality chair for the Nate Silverstein and Sky Rocket Sectionals due to Jackie Stewart's resignation.
- Mentor games for August November, 2013- Judy Knox
   The mentor game schedule was discussed. Judy Knox will still be in charge of the Mentor Games until the new Lightman Board decides otherwise since it is an M.A. Lightman Bridge Club game.
